All property within the following : ALONG THE

The special benefit district so created would be for the purpose of improving _____


After being constructed to County standards, the road or street will be accepted for County maintenance.

- b) 35% of the resident landowners owning at least 51% of the land within the district; or
- c) The owners of 60% of the land within the district.

The signatories herein petition the Board of County Commissioners of Leavenworth County, Kansas, pursuant to K.S.A. 17-201 and Chapter 17-201 of the Statutes of the State of Kansas, to create a special district composed of the following land:

All property within the following boundaries:

Section 15, Township 11 North, Range 22 East, Leavenworth County, Kansas. The special district created would be for the purpose of improving the streets and sidewalks on the south side of the intersection of Evans Road and South Street, Leavenworth, Kansas.

The signatories herein represent the following: a) 21% of the resident landowners owning at least 25% of the land within the district or b) 25% of the resident landowners owning at least 21% of the land within the district or c) The owners of 60% of the land within the district.

We understand the benefit district's assessment of the cost will be paid in full by the landowners.


After being submitted to County standards, the road or street will be accepted by County maintenance.
