The signatories hereto petition the Board of County Commissioners of Leavenworth County, Kansas, pursuant to K.S.A. 68-701 et seq. and Charter Resolution 1997-1, for the creation of a special benefit district composed of the following land:

West line of Section 29, Township 10 South, Range 22 East Leavenworth County, Kansas.

The special benefit district so created would be for the purpose of improving portion
of road between Leavenworth & Donchaw road/street (circle one) beginning at the _____

We understand the benefit district's assessment of the cost will be paid in not less than ten (10) and no more than twenty (20) annual installments.

- b) 35% of the resident landowners owning at least 51% of the land within the district; or
- c) The owners of 60% of the land within the district.
